BE IT KNOWN TO ALL MEN:

That ADRIANO D. EMPERADO, originator of the Kajukenbo style of self-defense and founder of the Kajukenbo Self-Defense Institute, having met the moral, physical and spiritual standards of the Kajukenbo Self-Defense Institute, Inc., a non-profit organization organized and existing under and by virtue of the laws of the State of Hawaii, under the powers vested in us by the Creators of the Kajukenbo style of self-defense, and pursuant to the rules and regulations of the Kajukenbo Self-Defense Institute, Inc., because of his exemplification of the meaning of the teachings of Kajukenbo philosophy as represented by his SPIRIT, MIND and BODY, we, the BOARD OF DIRECTORS of Kajukenbo Self-Defense Institute, Inc., do hereby bestow upon ADRIANO D. Be it further known that under the powers vested in this Board, we do hereby authorize and direct said PROFESSOR ADRIANO D. EMPERADO to teach the Kajukenbo style of Oriental Martial Arts to other worthy persons so that they too, like him, might promote the ideals and purposes of said organization for the good and betterment of all.

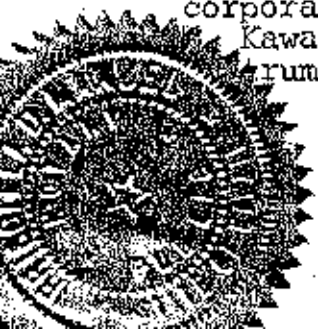

CHARTER OF INCORPORATION

TO ALL TO WHOM THESE PRESENTS SHALL COME:

I, the undersigned Director of Regulatory Agencies of the State of Hawaii,  
send Greeting:

WHEREAS, ROBERT T. KAWAKAMI, ADRIANO EMPERADO  
and FRANK ORDONEZ, all of whom are residents of the State  
of Hawaii, have filed with me as Director of Regulatory Agencies a verified peti-  
tion to grant to them and their associates a charter of incorporation as a non-  
profit corporation, in accordance with the provisions of Section 172-17, Revised  
Laws of Hawaii 1955, as amended;

NOW, THEREFORE, KNOW YE, That I, the said Director, in the exercise and  
execution of every power and authority in anywise enabling me in this behalf, do  
hereby constitute the said petitioners and their associates a corporation under  
the laws of the State of Hawaii for the purposes and in the form hereinafter set  
forth.

I

The name of the corporation shall be: KAJUKENBO SELF-DEFENSE  
INSTITUTE, INC.

II

The location of the principal office of the corporation shall be in  
City & County of Honolulu, State of Hawaii, and the specific address of its  
initial office shall be 3040 Kalihi Street, Honolulu,  
State of Hawaii.

III

The purposes of the corporation are: to promote the health and  
welfare of the public through the instruction and training in the

philosophy, technique, and development of the martial arts which lends tranquility of spirit through confidence, strength of body through good health and physical fitness, and the skill of self-defense in time of need, and the brotherhood of men working toward self-improvement; all toward the betterment of the community, the state and the nation.

IV

The duration of the corporation shall be perpetual.

V

The officers shall consist of: a president, executive vice-president, such assistant vice-presidents as the board of directors shall deem necessary, secretary, treasurer and such assistant secretaries or treasurers as the board of directors shall deem necessary.

VI

There shall be a board of directors consisting of not less than three members. The following persons shall be the initial officers and directors, and shall hold office for the first year or until their successors are duly elected pursuant to the by-laws of the corporation:

The corporation shall have all the powers provided by law.

VIII

The corporation is not organized for profit, it will not issue any stock, and no part of its assets, income, or earnings shall be distributed to its members, directors, or officers, except for services actually rendered to the corporation, and except upon liquidation of its property in case of corporate dissolution.
